FACEM Training Site Accreditation System Proposal Consultation

This survey requests your feedback on the proposed modifications to the system used to accredit sites for FACEM training (currently 6-month linked/6/12/18/24 months). It is envisaged that the revised system will apply to sites from 2022.

While this stakeholder consultation survey is focused on the Site Accreditation System, all proposed revisions to the FACEM Training Program, ACEM Curriculum Framework and the system of FACEM training site accreditation will be provided to internal and external stakeholders for a final period of consultation as advised in the November 2019 communique. The final consultation will be held in June/July 2020, prior to COE finalising a set of recommendations at its meeting scheduled for late July 2020 for the consideration of the ACEM Board.

Site Limits - A Three Tier System

A three-tier system of ED accreditation, based on the current system of accreditation, with corresponding requirements is proposed. This will replace the current 6-month linked, 6, 12, 18 and 24-month accreditation site limit system. It is envisaged that the revised site accreditation classifications will apply to all training sites from the beginning of the 2022 training year.

The proposed time limits include all core ED training. This core ED training time equates to 36 FTE months in the current three-phase training program (30 months core ED time in advanced training and 6 months discretionary training), and 42 FTE months in the proposed revised four-stage Training Program.

The time limits do not include:

- non-ED training time
- elective TS4 ED training time
- maintenance time; and
- remediation time.

While provisional training time is included in the revised proposal, the maximum provisional accredited training time that is accredited is 12 months. Any additional ED time during provisional training is maintenance time.

ACN considers these timeframes appropriate to ensure depth and breadth of experience for trainees. Feedback from ACN's members who have worked in several major trauma departments and rural emergency departments found their practice to be satisfactory.



FACEM Supervision

To optimise bedside safety, supervision, teaching and welfare of all staff, minimum requirements for supervision are proposed for each tier as described in the table below.

ACN suggests that tier 3 and Private Sites should have the same minimum supervision requirements.

Case mix

The following revised descriptions are proposed with respect to Adult/Mixed Public Emergency Departments:

For Tier 1, the site will, in general, have a similar profile to peer sites across case mix variables and associated resources. It is expected the site will, in general, have a comprehensive case mix with a broad range of acute and complex patients.

For Tier 2, the site will, in general, have a similar profile to peer sites across case mix variables and associated resources. It is expected the site will have a broad range of acute and complex patients; however, it is recognised that there may be limitations with respect to the numbers of some patient cohorts.



For Tier 3, the site will, in general, have a similar profile to its peer sites across case mix variables and associated resources. ACN recommends some variables to be taken into account as well as case mix for sites including: trauma, lay-out, Medical-led stream, percentage of paediatric presentations and percentage of Aboriginal and Torres Strait Islander presentations.

Training Stage 4

In the revised FACEM Training Program, trainees must undertake six (6) FTE months core ED training and six (6) FTE months elective (ED or non-ED) training in Training Stage 4. Following support expressed through the stakeholder feedback, it is proposed that in order to be accredited to provide Training Stage 4 training (core ED and/or elective), sites should be subject to additional accreditation requirements. These requirements will align to the learning outcomes specific to Training Stage 4 and aim to ensure that trainees are able to meet the requisite training and assessment requirements of this stage that focus on senior leadership and management skills.

Guidelines will be provided for non-ED rotations in TS4 to assist sites and trainees to understand the expectations but a formal TS4 accreditation will not be required. ACN considers the role of the Director of Research to be vital for maintaining clinical and technical coordinated education that is evidenced-based practice. This position could review and research the roles in the emergency department, productivity and contribute to medical education.

Please provide any further comments that you have regarding the proposed revisions to the system of site accreditation:

The revisions to the accredited site classification system appears to reflect the trainee's ownership in collaboration and communication with DENT, experience with different EDs and training limitations in sites which benefit the trainee. This will then promote recruitment to rural and remote sites with trainees/FACEMs whom have experience in a range of EDs with broad specialties.

The proposed revisions are clear with set role delineation and ED departments implementing the FACEM workforce model with timeframes.
