

DISTINGUISHED LIFE FELLOWSHIP APPLICATION

Distinguished Life Fellowship of ACN is awarded to Fellows for outstanding professional achievements and contributions.

Purpose: To recognise outstanding achievements and ongoing contributions to ACN and the profession.

Eligibility criteria

- Nominees must be residing in Australia
- Nominees with a minimum of ten years of ACN **Fellowship**
- Awards may be granted posthumously
- Nomination by spouse or significant other not accepted
- Unsuccessful nominees may be re-nominated in subsequent years
- Exceptional contribution to the nursing profession and to health care (locally, nationally and/or internationally) through clinical practice, education, research, policy and/or leadership
- Significant longstanding contribution to ACN including a continuous and current financial membership of ACN

Examples to address eligibility criteria

- ACN Board or other ACN committee representation
- Contribution to ACN policy submissions
- Contribution to ACN publication(s)
- Presentation at ACN event(s)
- Review of ACN Grants and Awards applications
- Active involvement in ACN Conferences and/or Forums
- Lead roles in an ACN State/Territory, Region, or Faculty
- Review ACN conference papers/articles
- Other personal, academic, or professional achievements

Note: Each nomination is to be accompanied by a completed ACN Distinguished Life Fellow (DLF) nomination form and the contact details of two referees (either two fellows or one member and one fellow) who each provide a *letter of support (up to 200 words) stating:*

- the capacity in which you have known the applicant/nature of your relationship to the applicant:
- the length of time you have known the applicant
- Words of support for the DLF appointment.

Note: when referencing involvement with ACN, this includes involvement with ACN's two founding organisations - Royal College of Nursing Australia (RCNA) and The College of Nursing (TCoN).
