# **ACN Emissions Reduction Charter**

Approved December 2020 **Review December 2022** 

This charter outlines the core beliefs and responsibilities all Australians have in aiding the reduction of carbon emissions. Nursing leadership is key to the health and aged care industries reducing emissions safely and effectively. The Australian College of Nursing (ACN) is committed to driving this agenda to support all nurses to champion change.

#### ACN:

- Believes nurses are vital stakeholders in driving sustainable development across the health care sector
- Prioritises ethical leadership<sup>1</sup> committed to reducing carbon emissions across the health care sector
- Develops and fosters inter-organisational partnerships with leading climate change organisations
- Engages and supports members and leaders to increase their climate literacy, advocacy and action through specified education, training, research and communication
- · Listens to and values the concerns of its members and stakeholders for whom climate change, and emissions reduction strategies will mostly impact
- Supports all nurses to advocate for and promote sustainable practices within their workplaces and communities
- · Believes that health care organisations should consider environmental consequences, and should reflect this when shaping and developing organisational policies
- Strongly advocates for the health care industry to provide a clean, safe, physical environment of high quality, and an ecosystem that is sustainable for the long term.

#### **ACN** supports the Australian Government to:

- Transition to **net zero carbon emissions** by the year 2040;
- · Prioritise emissions reduction as central to the global development agenda;
- Develop and implement the Climate and Health Alliance's Framework for A National Strategy on Climate, Health And Well-Being for Australia.2

# ACN calls on all governments, organisations and Australian nurses to:

- Implement strong organisational governance at board level to make emissions reduction a core responsibility and develop a statement of priorities that reflects emissions reduction across the organisation
- Contribute to and continue to support climate change research;
- · Prioritise emissions reduction as a requirement for health sector practice; and support inclusion of environmental considerations across health care policies
- · Develop a tool for measuring and evaluating every organisation's contribution to carbon emissions and opportunities for emissions reduction
- Consider recyclable reusable alternatives as specific as single use plastics and food waste use where plausible when considering all new products or tenders
- Prioritise emissions reduction as a key focus of sectors, communities and civil society.
